1. Citizenship in Zakistan

The Principality of Zakistan, a sovereign microstate, offers citizenship to individuals who meet specific criteria established under its legal framework. Zakistani citizenship confers various rights and responsibilities, including the right to reside and work in Zakistan, participate in civic life, and enjoy the protection of the Zakistani government. As a citizen, you will be part of a vibrant and growing community committed to the principles of democracy, cultural heritage, and innovation.

2. Laws Governing Citizenship

The laws governing citizenship in Zakistan are designed to ensure that new citizens are well-integrated into the community and committed to the values and laws of the principality. The primary legislation that regulates citizenship includes:

- The Citizenship Act of Zakistan (CAZ): This act outlines the requirements and processes for acquiring citizenship, including eligibility criteria and application procedures.
- The Nationality Code: This code defines the principles of nationality in Zakistan, including the rights and obligations of citizens.
- The Immigration and Residency Act: This act governs the conditions under which individuals can reside in Zakistan and outlines the pathways to permanent residency and citizenship.

These laws ensure that the process of becoming a citizen is transparent, fair, and rigorous, maintaining the integrity and values of Zakistan.

3. Constitution of Zakistan: Article 31

According to Article 31 of the Constitution of Zakistan, there are only three recognized ways to acquire Zakistani nationality:

1. Naturalization: This process is available to individuals who have fulfilled the residency and character requirements set forth by Zakistani law. Applicants must demonstrate their commitment to Zakistan, proficiency in the Zakistani language, and adherence to

Zakistani laws and values. Naturalization is a testament to an individual's dedication to becoming an integral part of Zakistan's society.

- 2. Jus Sanguinis (Right of Blood): Citizenship by descent is granted to individuals born to at least one Zakistani parent. This method ensures that the bond of nationality is preserved through generations of Zakistani families. It recognizes the importance of heritage and family ties in maintaining the cultural and social fabric of Zakistan.
- 3. Decree from the Highest Authority: In exceptional cases, the highest authority of Zakistan, the Prince, may grant citizenship by decree. This is reserved for individuals who have made extraordinary contributions to Zakistan or who are deemed to hold significant importance to the state. This discretionary power ensures that Zakistan can honor and integrate individuals who have shown outstanding dedication or potential for the principality.

4. Additional Information

Applicants should be aware of the following important aspects of the citizenship application process:

- Supporting Documents: All required documents must be certified copies. Failure to
 provide the necessary documentation will result in delays or rejection of your
 application.
- 2. Language Proficiency: Proficiency in the Zakistani language is mandatory. Applicants must provide evidence of their language skills through a certified language test or alternative proof.
- 3. Health and Character Assessments: Applicants must undergo health assessments and provide a police clearance certificate to demonstrate good character. These assessments ensure that new citizens will contribute positively to the community and uphold Zakistani values.
- 4. Community Involvement: Active involvement in the Zakistani community is highly valued. Evidence of community service, participation in local events, and other forms of civic engagement will strengthen your application. Community involvement demonstrates your commitment to the social and cultural life of Zakistan.
- 5. Pledge of Allegiance: All new citizens must take a pledge of allegiance to the Principality of Zakistan, affirming their loyalty and commitment to the state. This pledge is a solemn promise to uphold the laws, values, and principles of Zakistan.

1. La Citoyenneté au Zakistan

La Principauté du Zakistan, un micro-État souverain, qui offre la citoyenneté aux individus qui répondent à des critères spécifiques établis dans son cadre juridique. La citoyenneté zakistanaise confère divers droits et responsabilités, y compris le droit de résider et de travailler au Zakistan, de participer à la vie civique et de bénéficier de la protection du gouvernement zakistanais. En tant que citoyen, vous ferez partie d'une communauté dynamique et en pleine croissance, engagée dans les principes de la démocratie, du patrimoine culturel et de l'innovation.

2. Les Lois Régissant la Citoyenneté

Les lois régissant la citoyenneté de la Principauté Zakistanaise sont conçues pour garantir que les nouveaux citoyens sont bien intégrés dans la communauté et engagés envers les valeurs et les lois de la principauté. Les principales législations qui régissent la citoyenneté incluent :

- La Loi sur la Citoyenneté du Zakistan (LCZ) : Cette loi décrit les exigences et les processus pour acquérir la citoyenneté, y compris les critères d'éligibilité et les procédures de demande.

Les demandeurs doivent démontrer leur engagement envers le Zakistan, leur maîtrise d'une des trois langues officielles et leur adhésion aux lois et valeurs zakistanaises. La naturalisation est un témoignage de la dédication d'un individu à devenir une partie intégrante de la société zakistanaise.
- 2. Jus Sanguinis (Droit du Sang): La citoyenneté par descendance est accordée aux individus nés d'au moins un parent zakistanais. Cette méthode garantit que le lien de nationalité est préservé à travers les générations de familles zakistanaises. Elle reconnaît l'importance du patrimoine et des liens familiaux dans le maintien du tissu culturel et social du Zakistan.
- 3. Décret de la Plus Haute Autorité: Dans des cas exceptionnels, la plus haute autorité du Zakistan, le Prince, peut accorder la citoyenneté par décret. Cela est réservé aux individus qui ont apporté des contributions extraordinaires au Zakistan ou qui sont jugés d'une importance significative pour l'État. Ce pouvoir discrétionnaire garantit que la principauté peut honorer et intégrer des individus qui ont montré une dévotion ou un potentiel exceptionnel pour la principauté.

4. Informations Supplémentaires

Les demandeurs doivent être conscients des aspects importants suivants du processus de demande de citoyenneté :

- 1. **Documents à l'Appui**: Tous les documents requis doivent être des copies certifiées conformes. Le non-fournissement des documents nécessaires entraînera des retards ou le rejet de votre demande.
- 2. Maîtrise de la Langue : La maîtrise d'une des trois langues officielles est obligatoire. Les demandeurs doivent fournir des preuves de leurs compétences linguistiques par le biais d'un test de langue certifié ou d'une preuve alternative.
- **3.** Évaluations de Santé et de Caractère : Les demandeurs doivent subir des évaluations de santé et fournir un certificat de casier judiciaire pour démontrer leur bon caractère. Ces évaluations garantissent que les nouveaux citoyens contribueront positivement à la communauté et respecteront les valeurs zakistanaises.
- **4.** Engagement Communautaire: L'engagement actif dans la communauté zakistanaise est fortement valorisé. Des preuves de service communautaire, de participation à des événements locaux et d'autres formes d'engagement civique renforceront votre demande. L'engagement communautaire démontre votre dévouement à la vie sociale et culturelle du Zakistan.
- **5. Serment d'Allégeance** : Tous les nouveaux citoyens doivent prêter serment d'allégeance à la Principauté de Zakistan, affirmant leur loyauté et leur engagement envers l'État. Ce serment est une promesse solennelle de respecter les lois, les valeurs et les principes de Zakistan.
